ORDINANCE NO. 2008 – 9

AN ORDINANCE AMENDING PART ONE – ADMINISTRATIVE CODE, TITLE THREE – LEGISLATIVE, CHAPTER 121 – COUNCIL, SECTION 121.01 – RULES OF COUNCIL OF THE CODIFIED ORDINANCES OF THE CITY OF WILLOUGHBY HILLS AND REPEALING CONFLICTING LEGISLATION.

WHEREAS, the Council of the City of Willoughby Hills has requested the changes set forth by this Ordinance.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. Section 121.01, Subsection (a) be amended to read and provide in its entirety as follows:

“121.01 RULES OF COUNCIL.

The following are hereby adopted as Rules of Council:


- (a) **Regular Meetings, Time.** Regular Meetings of Council shall be held at such place as Council shall designate in the City on the second and fourth Thursday of each month at 7:00 p.m., except when such Thursday is a legal holiday. During the month of August, Council may, at its discretion, recess its Regular Meetings and may provide for Special Meetings during such period to be called by the Council President or any four (4) Members of Council. All meetings of Council, whether Regular or Special, shall be open to the public. By Resolution or Motion concurred in by a majority of members elected to Council, any Regular Meeting may be continued to any later period prior to the date of the next Regular Meeting, which such adjourned meeting shall be considered a Regular Meeting, but any absentee shall be notified personally by written notice, served personally, or at his regular place of residence, at least twelve (12) hours prior to the date and hour of the meeting.”

SECTION 2. All Ordinances, or parts thereof in conflict with the provisions of this Ordinance be, and are hereby repealed as of the effective date of this Ordinance.

SECTION 3. The actions of this Council concerning and relating to the passage of this legislation were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 4. This Ordinance shall be in full force and take effect at the earliest time permitted by law.


