ORDINANCE NO. 2009-4

AN ORDINANCE ACCEPTING THE BID OF XYBIX SYSTEMS, INC. OF LITTLETON, COLORADO FOR THE CONSOLE CABINETRY SYSTEMS FOR THE DISPATCH CENTER PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, the Mayor solicited bids for the **Public Safety Communications Center Renovation Project – Technology Package**; and

WHEREAS, the Council of the City of Willoughby Hills has reviewed and accepts the recommendation as provided by the Finance Director, finding the bid of **\$63,786.00** for – **Console Cabinetry Systems for the Dispatch Center Project** as received by **Xybix Systems, Inc.** to be the lowest bid to be in conformance with all contract requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to accept the bid of **\$63,786.00** for **Console Cabinetry Systems for the Dispatch Center Project** as submitted by **Xybix Systems, Inc. of 8207 Southpark Circle, Littleton, Colorado 80120**, substantially pursuant to the terms and conditions as identified in said **Bid Tabulation and Summary**, attached hereto as Exhibit A, consisting of (8) pages and incorporated herein by reference.

SECTION 2. The Director of Finance is authorized and directed to return all bid bonds to the unsuccessful bidders.

SECTION 3. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 4. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of a municipal department, and further reason being to allow the City to accept the bid and enter into a contract within 30 days as specified in the bid proposal of **Xybix Systems, Inc.**; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
