## **ORDINANCE NO. 2009-50**

---

**AN ORDINANCE AUTHORIZING THE EXPENDITURE OF FUNDS FOR THE PURCHASE OF TELEPHONE EQUIPMENT FOR THE CITY HALL COMPLEX PROVIDED THROUGH THE OHIO DEPARTMENT OF ADMINISTRATIVE SERVICES, OHIO COOPERATIVE PURCHASING PROGRAM FOR AN AMOUNT NOT TO EXCEED \$42,000.00 AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City Hall Telephone System is a critical portion of the City's Emergency Communications Systems and its failure would constitute a substantial risk to the safety, health and welfare of its residents; and

**WHEREAS**, the existing City Hall telephone system has exceeded its life expectancy and therefore is becoming non-serviceable due to limited part availability; and

**WHEREAS**, L-Tronics, Inc., the City's Technology Consultant, has submitted their Purchase Recommendation and a Sales Quotation received from AT&T, Inc., as provided through the State of Ohio Department of Administrative Services (State Term Contract STS-033, Nortel contract Number 573070-1-8) dated April 20, 2009, attached hereto as "Exhibit A", consisting of five (5) pages and referenced herein for the purpose of acquiring equipment for the City Hall Complex; and

**WHEREAS**, the City is purchasing this equipment through the Ohio Department of Administrative Services, Ohio Cooperative Purchasing Program for an amount not to exceed \$42,000.00.

***NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:***

**SECTION 1.** Council hereby authorizes the expenditure of funds for the purchase of one (1) Northern Telecom BCM450 including installation and personnel training, pursuant to the Ohio Department of Administrative Services, Ohio Cooperative Purchasing Program, Nortel Contract Number 573070-1-8..

**SECTION 2.** Said equipment is to be supplied by AT&T, Inc. of 45 Erieview Plaza, Cleveland, Ohio 44113 with said purchase not to exceed \$42,000.00.

**SECTION 2.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.


**SECTION 3.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the municipal department, and further reason being that this will allow the City to implement the equipment necessary to coordinate said installation with the ongoing project schedule; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.




