ORDINANCE NO. 2009-54

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO SIGN A RELEASE OF EASEMENT WITH SAID EASEMENT INITIALLY GRANTED TO THE VILLAGE OF WILLOUGHBY HILLS AND RECORDED IN VOLUME 485, PAGE 639 OF THE LAKE COUNTY RECORDS; REPEALING CONFLICTING LEGISLATION AND DECLARING AN EMERGENCY.

WHEREAS, on May 21, 1959 Council adopted <u>Resolution No. 1959-12</u> entering into a contract with Goldie Mittleman for the securing of certain easements, repairs and other appurtenances relating to Sleepy Hollow Estates, Subdivision in the Village of Willoughby Hills; and

WHEREAS, on September 3, 1959, Goldie Mittleman granted the Village of Willoughby Hills an easement as recorded on September 10, 2009 in Volume 485, Page 639 of the Lake County Records; and

WHEREAS, on February 23, 2009 City Council adopted <u>Ordinance No. 2009-6</u> authorizing and directing the Mayor to enter into a Real Estate Purchase Agreement for the sale of certain property located at 35360 Martin Road, Permanent Parcel No. 31A004C000150; and

WHEREAS, said real estate previously served as a waste water treatment plant and a pumping station which has since been abandoned and gravity sewers have been installed; and

WHEREAS, the City Engineer had determined that there is no public purpose for ownership of this real estate by the City of Willoughby Hills; and

WHEREAS, within said property lies the aforementioned easement as granted by Goldie Mittleman; and

WHEREAS, in furtherance of <u>Ordinance No. 2009-6</u>, the City of Willoughby Hills wishes to release said easement with the understanding that a new easement be granted to the City for storm sewer and drainage purposes by the purchasers of certain property located at 35360 Martin Road.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. In furtherance of the sale of real property with a mailing address of 35360 Martin Road, Willoughby Hills, Ohio, Lake County Permanent Parcel Number 31A004C000150, the Mayor be and is hereby authorized and directed to sign a *Release of Easement*, attached hereto as **Exhibit A**, consisting of three (3) pages. Said easement was initially granted to the Village of Willoughby Hills in <u>Resolution No. 1959-12</u> and recorded in Volume 485, Page 639 of the Lake County Records.

SECTION 2. Said easement grant from Goldie Mittleman to the Village (now City of Willoughby Hills) is a 20 foot wide strip across the front of Permanent Parcel No. 31A004C000150 with a mailing address of 35360 Martin Road.

SECTION 3. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 4. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of a Municipal Department, and further reason being that this Ordinance is required in order to proceed with and thereby finalize the sale of real estate located at 35360 Martin Road, Willoughby Hills, Ohio; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
