## ORDINANCE NO. 2009-83

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO SIGN AN ADDENDUM TO THE MASTER AGREEMENT BETWEEN AT&T GLOBAL SERVICES AND THE CITY OF WILLOUGHBY HILLS FOR THE SALE OF SUPPORT SERVICES FOR VOICE CUSTOMER PREMISE EQUIPMENT AND DECLARING AN EMERGENCY.

WHEREAS, on October 28, 2004, the Council of the City of Willoughby Hills adopted Ordinance No. 2004-54 authorizing the Mayor to enter into a Master Agreement with SBC Global Services to implement the upgrade of the City's 9-1-1 System; and

WHEREAS, AT&T Equipment Solutions Voice CPE Support Services offers support services for Voice Customer Premise Equipment; and

WHEREAS, said Addendum covers AT&T's Sale of and Support Services for Voice Customer Premise Equipment ("CPE" or "Equipment") under the attached Bill of Materials for Equipment and Services; and

WHEREAS, the addendum entered into by SBC Global Services, Inc. dba AT&T Global Services (AT&T) and the City of Willoughby Hills is an attachment to and made a part of that certain Master Agreement between the parties thereto;

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

**SECTION 1.** The Mayor is hereby authorized and directed to sign the Addendum to the Master Agreement between AT&T Global Services and the City of Willoughby Hills for the Sale of Support Services for Voice Customer Premise Equipment; said addendum identified as AT&T Equipment Solutions Voice CPE Support Services Attachment - Bill of Materials for Equipment and Services attached hereto as "Exhibit A", consisting of eight (8) pages, as referenced herein.

**SECTION 2.** Said Addendum provides AT&T Maintenance Services for an initial term consisting of five (5) years, from November 1, 2009 to October 31, 2014 at an annual price of \$5,915.40, payments are to be made monthly for a total amount not to exceed \$29,577.00.

**SECTION 3.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 4.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the municipal department; to wit: the initial term of service is to commence on November 1, 2009; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
