ORDINANCE NO. 2009 – 94

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO SOLICIT AND AWARD GENERAL TRADES CONSTRUCTION CONTRACTS WITH A TOTAL MAXIMUM ALLOWANCE OF \$25,000 FOR THE STARK DRIVE PUMP STATION IMPROVEMENTS AND DECLARING AN EMERGENCY.

WHEREAS, bids were received twice for the Corporate 90 & Stark Road Pump Station Rehabilitation; and

WHEREAS, bids for the referenced project greatly exceeded the probable opinion of the construction cost; and

WHEREAS, the City reviewed and concurs with the opinion of the City Engineer provided as Exhibit "A" , consisting of four (4) pages and attached hereto and will proceed with direct contracts for this project.


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, AND STATE OF OHIO THAT:


SECTION 1. The Mayor is hereby authorized and directed to solicit and award general trades construction contracts for the Stark Drive Pump Station Improvements at a cost not to exceed **\$25,000.00** in accordance with Chapter 115 of the City's Administrative Code.


SECTION 2. A copy of any and all awarded General Trades Construction Contracts for the Stark Drive Pump Station Improvements are to remain on file in Council Office.

SECTION 3. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 4. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of the municipality and further reason being that the awarding of contracts for this project must be coordinated with the Electrical Contract already awarded for this Contract; wherefore, this Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.


