## ORDINANCE NO. 2010-15

---

**AN ORDINANCE AMENDING PART ONE – ADMINISTRATIVE CODE, TITLE FIVE – ADMINISTRATIVE, CHAPTER 135 – DEPARTMENT OF FINANCE, BY THE ADDITION OF A NEW SECTION 135.34 – LAW ENFORCEMENT GRANTS FUND OF THE CODIFIED ORDINANCES OF THE CITY OF WILLOUGHBY HILLS AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City has been actively soliciting funding and grants for Safety Projects; and

**WHEREAS**, the Auditor of State has advised the City to establish, by Ordinance, any new funds and make application to the Bureau of Inspection when applicable; and

**WHEREAS**, the establishment of a new **Section 135.34 – Law Enforcement Grants Fund** will provide for the creation of a special revenue fund to receive grants, loans, appropriations or transfers and receipt expenditures for all legally approved expenditures for future Safety Projects.

***NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:***

**SECTION 1.** The existing **Chapter 135 – Department of Finance**, of the Codified Ordinances of the City of Willoughby Hills be, and the same hereby is, amended by the addition of a new **Section 135.34 – Law Enforcement Grants Fund** which shall read and provided in its entirety, as follows:

**“135.34        LAW ENFORCEMENT GRANTS.**

(a)        There is hereby created a fund to be known as the Law Enforcement Grants Fund. Funds received by the City as a result of grants, loans, and other legally approved transfers or appropriations for future Safety Projects together with all other sources of revenue attributable to the Fund or approved by Council shall be paid into this Fund.

(b)        Expenditures shall be made from the Law Enforcement Grants Fund to pay for expenses, supplies, services, and all other legally approved expenditures deemed necessary for the establishment of future Safety Projects with said expenditures to be recommended and approved by the Mayor and Finance Director or their designated alternatives.

(c)        The Director of Finance is hereby authorized and directed to make application to the Bureau of Inspection for approval of the creation of the Law Enforcement Grants Fund.”

**SECTION 2.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 3.** This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the Finance Department and further being that the creation of said fund will provide for the establishment of proper accounting of accumulated resources for future Safety Projects; wherefore, this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
