ORDINANCE NO. 2011-23

AN ORDINANCE DIRECTING THE MAYOR TO SIGN ANY AND ALL NECESSARY DOCUMENTS TO SECURE THE PURCHASE OF TWO (2) DODGE CHARGERS FROM GREVE DODGE FOR A TOTAL COST NOT TO EXCEED \$49,168.64 WITH SAID PURCHASE BEING EXEMPT FROM COMPETITIVE BIDDING PURSUANT TO SECTION 125.04 (C) OF THE OHIO REVISED CODE AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to the Police Department Memorandum from Chief Christopher J. Collins to Mayor/Safety Director Robert M. Weger, dated April 7, 2011, Police Chief Collins has respectfully requested approval for the purchase of two (2) Dodge Chargers from Greve Dodge., 750 West Ervin Road, Van Wert, Ohio; and

WHEREAS, in accordance with State Contract Law Enforcement Vehicle Specifications and pricing with available options, each of the Dodge Chargers would cost **\$24,584.32** for a total purchase price of **\$49,168.64** with said purchase price not to include the cost of equipment changeover, the installation and decaling which is estimated to an additional **\$6,000.00** per car; and

WHEREAS, the total estimated cost to purchase and outfit the cars would be **\$61,048.00**; and

WHEREAS, to continue the City's vital Police Car Rotation Program, started in 2003, the new Dodge Police Cars will be rotated into the Police Fleet and the older cars will be rotated out for disposal as surplus; and

WHEREAS, the Council of the City of Willoughby Hills accepts the recommendation of Mayor/Safety Director Weger to purchase two (2) police cars pursuant to the specifications for the City of Willoughby Hills Police Vehicles; and

WHEREAS, the Council of the City of Willoughby Hills approves of the immediate purchase of two (2) Dodge Chargers by utilizing funds from **#234 – Safety Forces Special Revenue Fund**.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:


SECTION 1. The Mayor is hereby authorized and directed to sign any and all necessary documents to secure the purchase of two (2) Dodge Chargers from Greve located at 750 West Erving Road, Van Wert, Ohio at a **total cost not to exceed \$49,168.64**. Said purchase price does not include the cost of equipment changeover, installation and decaling.


SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the Police Department, and further reason being that this will allow the City to utilize the price quotes as received from Greve Dodge without jeopardizing the availability of the vehicles; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.


