ORDINANCE NO. 2012 - 3

AN ORDINANCE TO ELECTRONICALLY PUBLISH THE CITY'S CODIFIED ORDINANCES THROUGH THE WALTER H. DRANE COMPANY.

WHEREAS, the Council of the City of Willoughby Hills wishes to continue to retain the professional codification services of The Walter H. Drane Company to provide periodic codification of the City's Codified Ordinances; and

WHEREAS, the Council of the City of Willoughby Hills wishes to afford the public easy and efficient access to the City's Codified Ordinances; and

WHEREAS, The Walter H. Drane Company offers a service whereby upon completion of an update of the City's Codified Ordinances, they host an electronic version on their website that is accessible via a link on the City's website.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The City of Willoughby Hills wishes to continue to retain The Walter H. Drane Company, 23811 Chagrin Boulevard, Suite 344, Beachwood, Ohio 44122-5525 to periodically provide professional codification services and prepare and publish updates of the City's Codified Ordinances.

SECTION 2. The City of Willoughby Hills wishes to also retain The Walter H. Drane Company, 23811 Chagrin Boulevard, Suite 344, Beachwood, Ohio 44122-5525 to host an electronic version of the City's Codified Ordinances on their website at an initial cost of \$3,000 with an annual maintenance fee, which is waived for the first year, of \$360.00.




SECTION 4. This Ordinance shall be in full force and effect at the earliest time permitted by law.


