ORDINANCE NO. 2012 – 4

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ACCEPT THE BID AND TO ENTER INTO A PURCHASE AGREEMENT WITH VALLEY FORD, STERLING FREIGHTLINER & WESTERN TRUCKS OF CLEVELAND FOR THE PURCHASE OF TWO 2012 MODEL 108SD CONVENTIONAL CHASSIS/SET BACK AXLE TRUCKS AT A TOTAL PRICE NOT TO EXCEED THE BASE BID OF \$151,824.00 FOR BOTH TRUCKS AND DECLARING AN EMERGENCY.

WHEREAS, on December 8, 2011, City Council, by motion, honored the Mayor's request by granting him authorization to advertise for bids for two 2012 or newer front snow plows, rear salt spreader dump trucks – GVWR 39,000 lbs; and

WHEREAS, the City advertised for bids with said bids opened on Thursday, December 22, 2011; and

WHEREAS, the City received the following 7 bids: Allstate Peterbilt for \$102,900.00, Kinstle Western Star for \$149,280.00 (includes equipment), Mac for \$96,900.00, Kenworth for \$89,964.00, International for \$72,824.00, Stoops Freightliner for \$126,874.00 (includes equipment) and Valley Freightliner for \$73,701.00; and

WHEREAS, the Council of the City of the Willoughby Hills has reviewed the recommendation provided by the Road Supervisor, Nate Catania in his Service Department Report on Vehicle Status submitted to Mayor Weger, on January 19, 2012 to accept the bid of Valley Freightliner with some additions being made to the package bringing the total purchase to \$75,912.00 for each cab and chassis with the dump bed, snow plow, salt spreader and lighting installed from Concord Road Equipment Company from Painesville, Ohio under the State of Ohio Purchasing Program at a cost of \$51,912.42 for each truck; and

WHEREAS, the Council of the City of Willoughby Hills approves of the immediate purchase of two 2012 front snow plows, rear salt spreader dump trucks: by utilizing funds from **Fund #250 – Street Construction, Maintenance & Repair and Fund #270 – Road Levy.**

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to enter into a purchase agreement with Valley Ford Sterling Freightliner & Western Trucks of Cleveland, 4985 West 150th Street, Brookpark, Ohio 44135 for the purchase of two 2012 Model 108SD Conventional Chassis/Set Back Axle Trucks at a base bid price of \$75,912.00 per truck; at a total amount not to exceed \$151,824.00, substantially pursuant to the terms and conditions as outlined in the Specification Proposal, dated January 10, 2012 attached hereto as "Exhibit A", consisting of (1) page and incorporated herein by reference.

SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were conducted in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 3. This Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as it provides for the usual daily operation of the Service Department; to wit: to immediately secure the base bid price of \$151,824 for both trucks as provided by Valley Ford Sterling Freightier & Western Trucks of Cleveland in the Specification Proposal, dated January 10, 2012; wherefore this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor.
