AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO CONTRACT WITH CT CONSULTANTS, INC. TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR THE DESIGN AND CONSTRUCTION ENGINEERING FOR THE EUCLID CREEK EAST BRANCH IMPROVEMENTS AND DECLARING AN EMERGENCY.

WHEREAS, the City of Willoughby Hills has experienced repeated flooding incidents over many years along the East Branch to the Euclid Creek, particularly in the area of Lamplighter Estates; and

WHEREAS, the City engaged CT Consultants, Inc. to conduct two (2) separate studies and hydrologic/hydraulic analyses to mitigate the flooding in the year 2000 and in the year 2011; and

WHEREAS, the City also directed CT Consultants, Inc. to seek funding opportunities and file grant applications to finance the recommended improvements over the years; and

WHEREAS, the City was recently successful in obtaining funding from the Lake County Stormwater Management Department (LCSMD) for the entire project cost including engineering and construction; and

WHEREAS, the City has determined that CT Consultants, Inc. is the best qualified firm to provide engineering services for the project due to the firm's understanding, prior knowledge and history of the project and for its specific expertise in such improvements; and

WHEREAS, the City has elected to proceed with the Euclid Creek East Branch Improvements at the earliest possible time to complete construction this year; and, wishes to now authorize that professional engineering services be provided for the project.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to enter into contract with CT Consultants, Inc. to provide design and construction-related engineering services for the Euclid Creek East Branch Improvements substantially pursuant to the terms and conditions as identified in the Work Authorization and Letter dated February 7, 2012 attached hereto and consisting of two pages and incorporated herein by reference, at a total cost not to exceed \$57,000; and, in accordance with the Engineering Agreement dated April 17, 2007.

SECTION 2. The actions of this Council concerning and relating to the passage of legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.
