## **RESOLUTION NO. 2008 – 3**

**A RESOLUTION NOTIFYING THE CUYAHOGA COUNTY COMMISSIONERS THAT THE CITY OF WILLOUGHBY HILLS WILL CONTINUE TO FIGHT ANY AND ALL RUNWAY EXPANSION OF THE CUYAHOGA COUNTY AIRPORT AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Council and Administration of the City of Willoughby Hills strongly oppose any and all runway expansion of the Cuyahoga County Airport; and

**WHEREAS**, the Council and Administration of the City of Willoughby Hills have and will continue to fight any and all runway expansion of the Cuyahoga County Airport including but not limited to Alternative 38 as proposed by the Cuyahoga County Commissioners; and

**WHEREAS**, the Council and Administration of the City of Willoughby Hills will continue to fight any and all runway expansion of the Cuyahoga County Airport on a Federal Level, on a County Level and on a Municipal Level.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:**

**SECTION 1.** This Council and Administration hereby oppose and will continue to fight any runway expansion of the Cuyahoga County Airport; deeming any expansion in the size or use of the Cuyahoga County Airport to be hazardous to the public health, safety and general welfare of the City and the residents of the City of Willoughby Hills.

**SECTION 2.** The Clerk of Council is hereby directed to forward certified copies of this Resolution to the Federal Aviation Administration, the Cuyahoga County Commissioners and all appropriate State and Federal elected representatives.


**SECTION 3.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 4.** This Resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual operation of a municipal department and for the further reason that it is urgent to move forward with said Resolution to notify the Federal Aviation Administration, the Cuyahoga County Commissioners and all appropriate State and Federal elected representatives that the City of Willoughby Hills is in opposition to any and all runway expansion, including but not limited to Alternative 38; wherefore this Resolution shall be in full force and effect from and after its adoption and approval by the Mayor.




