A RESOLUTION AUTHORIZING THE CITY OF WILLOUGHBY HILLS TO ACCEPT THE AMOUNTS AND RATES FOR THE YEAR 2010 AS DETERMINED BY THE BUDGET COMMISSION OF LAKE COUNTY, OHIO AND AUTHORIZING THE NECESSARY TAX LEVIES AND THE CERTIFICATION THEREOF TO THE COUNTY AUDITOR; AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the City of Willoughby Hills adopted <u>Ordinance No. 2009-59</u>, on July 23, 2009 thereby, and in accordance with the provisions of law, adopting a Tax Budget for the next succeeding fiscal year commencing January 1, 2010; and

WHEREAS, The Budget Commission of Lake County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within, the ten mill tax limitation; and

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.

<u>SECTION 2</u>. There be and is hereby levied upon the tax duplicate of the City of Willoughby Hills the rate of each tax necessary to be levied within and without the ten mill limitation substantially pursuant to and as identified in Schedule A, Summary of Amounts Required From General Property Tax Approved By Budget Commission, and County Auditors Estimated Tax Rates and Schedule B, Levies Outside 10 Mill Limitation, Exclusive of Debt Levies, attached hereto as "Exhibit A", consisting of (2) pages and incorporated herein by reference.

SECTION 3. The Finance Director be and is hereby directed to provide a certified copy of this Resolution to the Auditor of Lake County by October 1, 2009 pursuant to State Law.

SECTION 4. The actions of this Council concerning and relating to the passage of legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 5. This Resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the City of Willoughby Hills; insofar as it provides for the usual daily operation of a Municipal Department, to wit: pursuant to State Law, certified copies must be submitted to the Auditor of Lake County by October 1, 2009 as approved by said Resolution; wherefore, this Resolution shall be in full force and take effect immediately upon its adoption by Council and approval by the Mayor; otherwise, it shall be in full force and effect at the earliest time permitted allowed by law.
