## **RESOLUTION NO. 2010-6**

---

### **A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR TO FILE AN APPLICATION WITH THE OHIO PUBLIC WORKS COMMISSION FOR FUNDS NECESSARY FOR THE EDDY ROAD IMPROVEMENTS AND DECLARING AN EMERGENCY.**

---

**WHEREAS**, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure; and

**WHEREAS**, the City of Willoughby Hills has identified that Eddy Road from SOM Center Road to River Road is in need of drainage and roadway improvements; and

**WHEREAS**, the City is pursuing funding from the Ohio Public Works Commission to help offset the cost of the improvements; and

**WHEREAS**, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs.

***NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:***

**SECTION 1.** The Mayor be, and he hereby is, authorized and directed to file an application with the Ohio Public Works Commission for funds necessary for the Eddy Road Improvements.

**SECTION 2.** The Mayor is further authorized to execute any and all additional documents and forms necessary to properly secure such funding and to enter into contracts for said Projects.

**SECTION 3.** The Council and Administration of the City of Willoughby Hills hereby request the State of Ohio to consider and fund its applications for Ohio Public Works Commission funding.

**SECTION 4.** The actions of this Council concerning and relating to the passage of legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.


**SECTION 5.** This Resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills insofar as it provides for the usual daily operation of a municipal department and further to insure the timely filing of the application, same being deemed necessary for the preservation of the health, safety and welfare of the citizens of the City of Willoughby Hills, wherefore this Resolution shall be in full force and effect from and after its adoption and approval by the Mayor.


