RESOLUTION NO. 2012-1

A RESOLUTION APPROVING THE LAKE COUNTY SOLID WASTE MANAGEMENT DISTRICT'S AMENDED PLAN/5 YEAR UPDATE (DECEMBER, 2011) COMPLETED BY THE LAKE COUNTY SOLID WASTE MANAGEMENT COMMITTEE.

WHEREAS, the Board of County Commissioners of Lake County established the Lake County Solid Waste Management District (the "District") and convened a "Solid Waste Management Policy Committee" (the "Policy Committee") in accordance with Section 3734 of the Ohio Revised Code to prepare a "Solid Waste Management Plan" (the "Plan") for the District as required by Section 3734.54; and

WHEREAS, the District's original Solid Waste Management Plan was approved by Ohio EPA on September 1, 1992 and the last plan update was approved by Ohio EPA on February 26, 2006; and

WHEREAS, pursuant to Section 3734.56 of the Ohio Revised Code, the Solid Waste Management District Policy Committee reviewed the Plan, and submitted an Amended Plan/5 Year Update, which was subject to a thirty (30) day public comment period followed by a public hearing conducted on November 9, 2011; and

WHEREAS, the Policy Committee of Lake County Solid Waste Management adopted the Amended Plan/5 Year Update on November 16, 2011; the Amended Plan/5 Year Update now must be considered by all political jurisdictions in the District; and

WHEREAS, the ratification process began December 9, 2011 and must be completed by March 9, 2012; the Amended Plan/5 Year Update must be ratified prior to submittal to the Ohio EPA.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Council and Administration of the City of Willoughby Hills hereby approves the Lake County Solid Waste Management District's Amended Plan/5 Year Update (December, 2011)) as submitted to Council and presently on file with the Clerk of Council and the Administration.

SECTION 2. The Clerk of Council is hereby authorized and directed to mail or otherwise deliver promptly a certified copy of this Resolution to the Solid Waste Management District Coordinator.

SECTION 3. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements, including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 4. This Resolution shall be in full force and effect at the earliest time permitted by law.
