A RESOLUTION AUTHORIZING THE SUBMITTAL OF AN APPLICATION TO PARTICIPATE IN LAKE COUNTY'S 2012 COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM TO SEEK FUNDING IN THE AMOUNT OF \$50,000 FOR THE CITY'S RESIDENTIAL SANITARY SEWER SERVICE CONNECTION PROGRAM.

WHEREAS, the Department of Housing and Urban Development (HUD) provides Community Development Block Grant Entitlement Communities Grants; and

WHEREAS, the Program provides annual grants on a formula basis to entitled cities and counties to develop viable urban communities by providing decent housing and a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons; and

WHEREAS, the Department of Urban Development (HUD) awards grants to entitlement community grantees to carry out a wide range of community development activities directed toward revitalizing neighborhoods, economic development, and providing improved community facilities and services; and

WHEREAS, in 2011 the Board of Lake County Commissioners was the recipient of Housing Rehabilitation Program Funds from the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, fifty thousand dollars (\$50,000) of Community Development Block Grant Funds had been approved by the Board of Lake County Commissioners; and

WHEREAS, the City was the recipient of said Funds for the purposes of the RESIDENTIAL SANITARY SEWER SERVICE CONNECTION PROGRAM as provided for in the overall Housing Rehabilitation Program; and

WHEREAS, Lake County will be submitting the FY 2012 Action Plan, as part of the 2012-2014 Consolidated Plan, to the Department of Housing and Urban Development (HUD); and

WHEREAS, the City of Willoughby Hills wishes to participate in the 2012 Community Development Block Grant Program to seek additional funding in the amount of \$50,000 for the operation of the City's Residential Sanitary Sewer Service Connection Program; a program designed to improve the housing conditions of incomeeligible residents living in Willoughby Hills by providing access to safe, basic, and sound public sanitary sewerage treatment.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Mayor is hereby authorized and directed to submit an application on behalf of the City of Willoughby Hills to participate in Lake County's 2012 Community Development Block Grant Program seeking funds in the amount of \$50,000 for the continuance of the City's Residential Sanitary Sewer Service Connection Program to assist income qualified (low-moderate income) residents by providing access to safe, basic and sound public sanitary sewerage treatment.

SECTION 2. The actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.
