## RESOLUTION NO. 2016 - 7

### A RESOLUTION RECOGNIZING THE CITY'S PUBLIC SAFETY DISPATCHERS FOR THEIR DEDICATED SERVICE TO THE CITY OF WILLOUGHBY HILLS.
