## RESOLUTION NO. 2017-2

### **A RESOLUTION ADOPTING THE UPDATED LAKE COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN AS PRESENTED AND WITH ANY FEDERALLY-REQUIRED MODIFICATIONS.**

**WHEREAS**, natural, technological, and man-made hazards can affect the City of Willoughby Hills; and

**WHEREAS**, significant structural, historical, and economic losses could result from an occurrence of a natural, technological, or man-made hazard events; and

**WHEREAS**, undertaking mitigation projects during pre-disaster periods could decrease the total losses the City of Willoughby Hills incurs as a result of said hazard occurrences; and

**WHEREAS**, the City of Willoughby Hills Council has partnered with the County to update the existing *Lake County Multi-Jurisdictional Hazard Mitigation Plan*, adopted in October 2004, in an effort to further identify, define, and characterize the hazards affecting the city as well as to continue identifying and prioritizing projects that could lessen hazard vulnerability; and

**WHEREAS**, the City of Willoughby Hills Council has a strong interest in reducing losses from future hazard occurrences; and

**WHEREAS**, the hazard mitigation plan is a federal and state requirement to maintain eligibility for hazard mitigation funding, and, by that requirement, must be updated a minimum of every five (5) years; and

**WHEREAS**, a cooperative, joint effort is a proven, efficient way to plan for and reduce hazard susceptibility in all government jurisdictions in Lake County; and


**WHEREAS**, the City of Willoughby Hills joined Lake County in the completion of this plan update.





**SECTION 2.** This Resolution shall be in full force and effect at the earliest time permitted by law.
