A RESOLUTION ACKNOWLEDGING WILLOUGHBY-EASTLAKE’S SCHOOL OF INNOVATION AS ONE OF FOUR SCHOOLS THROUGHOUT THE STATE TO RECEIVE THE “ALL A AWARD.”

WHEREAS, the Ohio Board of Education on November 14, 2017 recognized schools around the state for various awards, based on the school’s report cards; and

WHEREAS, to qualify for the “All A Award,” schools must receive A’s on all of its applicable report card measures; and

WHEREAS, the six component measures include: **K-3 Literacy** – this component looks at how successful the school is at getting a struggling reader on track to proficiency in third grade and beyond; **Progress** – this component of the report card looks closely at the growth that all students are making based on their past performances; **Achievement** component of the report card represents the number of students who passed the state tests and how well they perform on them; **Gap Closing** – this component shows how well schools are meeting the performance expectations for our most vulnerable populations of students in English language arts, math and graduation, so that all of Ohio’s students can be successful; the **Graduation Rate** component looks at the percent of students who are successfully finishing high school with a diploma in four or five years and the **Prepared for Success** component looks at how well prepared Ohio’s students are for all future opportunities; and

WHEREAS, the “All A Award” is affirmation of a school’s commitment to providing the educational support needed to help every student perform to his or her capability.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The City Council of Willoughby Hills hereby recognizes the Willoughby-Eastlake’s School of Innovation for achieving the “All A Award” as presented by the Ohio Board of Education.
