RESOLUTION NO. 2015-6

A RESOLUTION TO ACCEPT A SAFETY GRANT IN THE AMOUNT OF \$40,000 FROM THE OHIO BUREAU OF WORKERS COMPENSATION AND DECLARING AN EMERGENCY.

WHEREAS, the Fire Department submitted an application for a “Safety Grant” in the amount of \$40,000 from The Ohio Bureau of Workers Compensation; and

WHEREAS, the purpose of the Safety Grant is to equip the City’s ambulances with Power Lift Cots and to provide one ambulance with a Power Load System for the cot; and

WHEREAS, the purchase of power cots with accessories will potentially reduce the risk of injury related to repetitive motion and manually lifting and loading/unloading patients into and out of emergency vehicle; this intervention will improve the process of patient handling and lifting.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:

SECTION 1. The Council of the City of Willoughby Hills hereby accepts the Safety Grant in the amount of \$40,000 from The Ohio Bureau of Workers Compensation. Said funds shall be used exclusively for equipping the City’s ambulances with Power Lift Cots and to provide one ambulance with a Power Load System for the cot.

SECTION 2. In accordance with State Statutes and the Codified Ordinances of the City of Willoughby Hills, the Mayor serving as Safety Director is hereby authorized to execute any and all other documents necessary to carry out the terms of the Grant Agreement.

SECTION 3. The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

SECTION 4. This Resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as providing for the usual daily operation of the Fire Department to wit: upon receipt of said grant funds, the City must purchase the equipment and implement the intervention within 90 days of the date of the grant check; wherefore, this Resolution shall be in full force and effect on and after its passage and approval by the Mayor.
