## **RESOLUTION NO. 2015-7**

---

**A RESOLUTION ESTABLISHING A SCHOOL ZONE FOR THE WILLOUGHBY-EASTLAKE SCHOOL OF INNOVATION LOCATED AT 32500 CHARDON ROAD IN WILLOUGHBY HILLS, OHIO BY PROVIDING THE PROPER SIGNAGE AND PAVEMENT MARKINGS; AND DECLARING AN EMERGENCY.**

**WHEREAS**, in 2014 the Willoughby-Eastlake School District purchased property at 32500 Chardon Road and beginning in August 2015, in accordance with Section 3301.16 of the Ohio Revised Code, intends to operate a chartered school; and

**WHEREAS**, “school” means any school chartered under Ohio R.C. 3301.16; and

**WHEREAS**, it is prima-facie lawful, in the absence of a lower limit declared or established pursuant to Ohio R.C. 4511.21 by the Ohio Director of Transportation or Council, for the operator of a motor vehicle to operate the same at a speed not exceeding the following: Twenty miles per hour in school zones during school recess and while children are going to or leaving school during the opening or closing hours and when twenty miles per hour school speed limit signs are erected; and

**WHEREAS**, “school zone” means that portion of a street or highway passing a school fronting upon the street or highway that is encompassed by projecting the school property lines to the fronting street or highway; and

**WHEREAS**, the City Council of Willoughby Hills has determined the necessity for this Resolution in order to preserve the health, safety and well-being of the residents, citizens and inhabitants of the municipality; therefore, in accordance with Chapter 7 of the Ohio Manual of Uniform Traffic Control Devices (OMUTCD) said school zone shall be properly identified with signage and pavement markings.

***NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:***

**SECTION 1.** In accordance with State Statutes and the Codified Ordinances of the City of Willoughby Hills, and in cooperation with the Willoughby-Eastlake School District, the Mayor serving as Safety Director is hereby authorized to execute any and all documents as well as take the appropriate actions necessary in order to provide the proper signage and pavement markings depicted in the **School Zone Marking Detail**, consisting of two (2) pages and attached hereto as the **“Exhibit A”**.

**SECTION 2.** The actions of this Council concerning and relating to the passage of this legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 3.** This Resolution constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the City of Willoughby Hills, insofar as providing for the usual daily operation of a municipal department, to wit: this directive must be in effect to allow for timely installation of required signage and pavement markings to insure the safety of the inhabitants of the municipality; wherefore, this Resolution shall be in full force and effect on and after its passage and approval by the Mayor.
