#### Order of Business

#### **Presentation of Vanity Fair business proposal.** Submitted written binder.

Christian Haffey. 2871 Camelot Ct. Reported educational background, and restaurant background.

Trucking Domino Logistics...Liquidated – going out of business. Now available to pursue this work. Chair inquired if others present were part of project team. CH introduced 2 others.

He would be CEO and managing partner. This proposal is akin to Cleveland's Nautica Charity Poker in Cleveland. WH offers a better, suburban location. Poker Pro is the company he would work with...Has Electronic dealer, therefore, don't need as many volunteers. Faster, no mistakes. The charity gets 10% of pot at a table. City of WH benefits: City charges \$200 per day to charity. Added Police presence. 20-50 employees and income tax. Local charities or we can set up a committee to select charity groups – open to how. Increased traffic to local retailers.

<u>August Garafoli</u> – CPMG Realty as agent for Spiegel Properties. He would like to see this happen. Big box retail is not coming back.

<u>Jack Fay</u>. 12816 Auburn Rd. Architectural design. 3 weeks into developing plans. Likes patrol, safety, using 20% of the VF space can attract to the other 80%.

Discussion: REICHELT: What is the City involvement? HAFFEY: You can resolve the legal issues. The City is the lessee. LOBE: The Ohio Charity Services LLC. Cannot 100% limit liability. SOMICH: Spoke with owner directly, met with Chief Collins, no concerns about safety. This isn't a dress shop, would love to have that sort of thing, but talked to many real estate people, those opportunities are not out there.

GARAFOLI: This is a perfect for us in this venue. Willing to write the lease with no liability. LOBE, A governmental unit is needed. BIRO: Have you approached other cities or areas. CH: Other than Nautica, this is it. B: We are surrounded by residential. HAFFETY: Yes. Done a lot of research on Nautica. Other charities are making \$50k over 4 days. FIEBIG: This proposal has no forecast, no numbers other than a potential, no demographics, research. Where is the cash flow if, by law, no salary may be paid to operators? HAFFEY: Concessions, Catering, Renting a table. DF: Employees – if volunteers, how can you state up to 50? Cleaning, police, manager, auditors. MALECEK: Most likely here to be for gaming, but this plan...We need a financial proposal. City on the line. HAFFETY: Charity pays all expenses, DF: That means a charity pays your utilities, CAM, insurances, heat, water, everything? Yes. GARAFOLI: Want a radical permissible tenant. MALECEK: You are asking us to be an investor, must see more solid numbers. GARAFOLI: Ten year deal. Maybe five. Voter referendum shows 66% passage approves gambling. GERMANO: Have you approached other entities? No. CHRIS McCAULEY. Introduced as a consultant to this project. AG opinion is that there is no liability to City. REICHELT: Would City officers be used (off-duty)? CM: Yes, others would be LAKE CO. SHERRIFF. R: What about the use of squad car. Can it be called away? Yes. How would signage, marketing, Charity Event Center. Gambling Hall feel not good. HAFFEY: WH has control over signage. Wants to open before casino downtown to establish customers. DR: Vegas has a gaming commission, What kind of oversight? You can check our books anytime. DR: Is it consistent with zoning? Other retail attraction to fill space. Only 6k is City lease, for gaming tables. \$200 per day - open 365 days. FIEBIG: Really? Ok only 360 days. REICHELT: Residents' concerns about image of internet cafes. Perception of signs. Signs could be regulated for content as well as other - even NAME. GERMANO: Not against but we need to consider all legal. LOBE: Impossible to write out liability. FG: Post a bond? Could have potential. Garafoli: landlord, tenant would all agree to indemnify. 24-40 generate per day. 8k per day, rent util, employees, parking, lease for recorder. LEASE runs out in April for VF – last lessee. FIEBIG: Policy #6 of Council does not allow contributions to charity. SOMICH: That was for direct donations. Discussion about why that is and the impact on choosing which charity might get into the event center – DF: Does the City appear to sponsor the charity since City is the lessee? Overall, much more discussion/information is needed, plan does not appear ready/many questions/unresolved. BIRO: People are not happy with gambling – image in the City; Son's group does school charity – 35k to support sports program. He participated. Run very well at Nautica. But we need to get more info. GERMANO: Believe could be a quality type thing, fills a vacancy, puts people to work. But a lot of questions. BIRO: Agree. Appreciate your time and discussion. Thinking outside the box is positive.

#### REF: 2915.02 Gambling.

- (A) No person shall do any of the following:
- (1) Engage in bookmaking, or knowingly engage in conduct that facilitates bookmaking;
- (2) Establish, promote, or operate or knowingly engage in conduct that facilitates any game of chance conducted for profit or any scheme of chance;
- (3) Knowingly procure, transmit, exchange, or engage in conduct that facilitates the procurement, transmission, or exchange of information for use in establishing odds or determining winners in connection with bookmaking or with any game of chance conducted for profit or any scheme of chance;
- (4) Engage in betting or in playing any scheme or game of chance as a substantial source of income or livelihood:
- (5) With purpose to violate division (A)(1), (2), (3), or (4) of this section, acquire, possess, control, or operate any gambling device.
- (B) For purposes of division (A)(1) of this section, a person facilitates bookmaking if the person in any way knowingly aids an illegal bookmaking operation, including, without limitation, placing a bet with a person engaged in or facilitating illegal bookmaking. For purposes of division (A)(2) of this section, a person facilitates a game of chance conducted for profit or a scheme of chance if the person in any way knowingly aids in the conduct or operation of any such game or scheme, including, without limitation, playing any such game or scheme.
- (C) This section does not prohibit conduct in connection with gambling expressly permitted by law.
- (D) This section does not apply to any of the following:
- (1) Games of chance, if all of the following apply:
- (a) The games of chance are not craps for money or roulette for money.
- (b) The games of chance are conducted by a charitable organization that is, and has received from the internal revenue service a determination letter that is currently in effect, stating that the organization is, exempt from federal income taxation under subsection 501(a) and described in subsection 501(c)(3) of the Internal Revenue Code.
- (c) The games of chance are conducted at festivals of the charitable organization that are conducted either for a period of four consecutive days or less and not more than twice a year or for a period of five consecutive days not more than once a year, and are conducted on premises owned by the charitable organization for a period of no less than one year immediately preceding the conducting of the games of chance, on premises leased from a governmental unit, or on premises that are leased from a veteran's or fraternal organization and that have been owned by the lessor veteran's or fraternal organization for a period of no less than one year immediately preceding the conducting of the games of chance.

A charitable organization shall not lease premises from a veteran's or fraternal organization to conduct a festival described in division (D)(1)(c) of this section if the veteran's or fraternal organization already has leased the premises twelve times during the preceding year to charitable organizations for that purpose. If a charitable organization leases premises from a veteran's or fraternal organization to conduct a festival described in division (D)(1)(c) of this section, the charitable organization shall not pay a rental rate for the premises per day of the festival that exceeds the rental rate per bingo session that a charitable organization may pay under division (B)(1) of section  $\underline{2915.09}$  of the Revised Code when it leases premises from another charitable organization to conduct bingo games.

(d) All of the money or assets received from the games of chance after deduction only of prizes paid out during the conduct of the games of chance are used by, or given, donated, or otherwise transferred to,

any organization that is described in subsection 509(a)(1), 509(a)(2), or 509(a)(3) of the Internal Revenue Code and is either a governmental unit or an organization that is tax exempt under subsection 501(a) and described in subsection 501(c)(3) of the Internal Revenue Code;

(e) The games of chance are not conducted during, or within ten hours of, a bingo game conducted for amusement purposes only pursuant to section <u>2915.12</u> of the Revised Code.

No person shall receive any commission, wage, salary, reward, tip, donation, gratuity, or other form of compensation, directly or indirectly, for operating or assisting in the operation of any game of chance.

- (2) Any tag fishing tournament operated under a permit issued under section <u>1533.92</u> of the Revised Code, as "tag fishing tournament" is defined in section <u>1531.01</u> of the Revised Code;
- (3) Bingo conducted by a charitable organization that holds a license issued under section <u>2915.08</u> of the Revised Code.
- (E) Division (D) of this section shall not be construed to authorize the sale, lease, or other temporary or permanent transfer of the right to conduct games of chance, as granted by that division, by any charitable organization that is granted that right.
- (F) Whoever violates this section is guilty of gambling, a misdemeanor of the first degree. If the offender previously has been convicted of any gambling offense, gambling is a felony of the fifth degree.

#### Order of Business

- 1) **Monitor Fee:** It is the desire of the Recreation Coordinators based on information, safety concerns, and revenue that a monitor fee of \$10.00 per hour (calculated by the Finance Director based on an average of the monitor's wages) is charged to non-profit organizations that are not charged a fee for the room after hours (4:30 p.m. and on Saturday and Sunday). Councilman Reichelt voiced concerns with charging non-profits a monitor fee. We could go a lot further with building civic relationships, without charging a monitor fee. Councilman Fiebig agreed; feel we should be providing the community with a center to meet, especially for non-profit organizations. Question poised how much would this really amount to? Council President Malecek suggests that whatever changes are made with the policy or ordinance should be made in accordance or guidance from the Law Director and State Auditor.
- 2) Councilman Reichelt suggests that an energy conservation review may be in order to save on our utility charges at the Community Center.

- 3) It was a recommendation from the Committee that monitor fees not be charged at this time.
- 4) Recreation Coordinator Anne Hassoldt-Fenoff suggests the Codified Ordinance TITLE FIVE- Other Public Services Chapter 941 Sections (g) and (j) needs to be revised. It was the consensus of the Committee suggesting that the Recreation Coordinators, along with the Mayor and the Mayor's Executive Assistance review these sections and bring back to the committee their recommendations and rational for any changes, including fees and criteria.

At a later date a review of those bodies that have not been charged and why, and those that have been charged and why, if it is outside our Ordinance will take place.

#### Public Portion

<u>The following individual came forth with questions/comments</u>: Frank Cihula, speaking for the WH Historical Society, if a monitor is charged, that fee should be taken against the \$1,700 and monetary items donated to the Community Center. Frank does not see a need for the monitor as the Society cleans-up after themselves. Concerning the Senior Room – numerous grants have been applied; possibly use these funds to deter a monitor fee.

**Deer Management Discussion** – would like to see a mocked-up ordinance at our next Rules Meeting for permitting bow on acreage at 5 or over.

Snowplowing at next meeting on October 24<sup>th</sup> – Councilman Germano to coordinate with Clerk. Ordinance 2011-4 – past years – chaotic mess on the East side – residents did to the streets – they plowed one side and pushed snow across the street to a "vacant lot" – windrows of snow. Plowing street – did not even look like I plowed it. Came up with ordinance – City of Wickliffe and City of Lyndhurst – few modifications – covers all things. Permit required fee – snowplow licensing – wanted to remove it. Wanted it in – adding a lot of workload on us. Put the burden on them – another level of legal stance – turned out they did something wrong – had a prior conviction. You cannot push snow into the right-of-way or into vacant lots – free for all. East side especially it is a problem. Main concern – push across – our trucks go down – clear one side

and the other. We have registration and asking for properties they are plowing – everything will be registered. In practicality - in middle of foot of snow - doing all of these jobs - they are not going to be come back - as long as they are registered for some property. Complaint driven. Other places just have a fine – put jail time into this – better clean this road up. Will a contractor not want to work here - \$5.00 for each vehicle. We are doing this for the accountability. Only for money – as long as no money is involved. Could put enaction clause Will review again at next Rules meeting – possible enaction this year, but taking effect next year. State just added a Sales tax onto the service – forget Willoughby Hills – hassle – get a snowplow contractor – postage stamp size – one acre, two acre – snow in the street, who is liable

#### **Public Portion**

Frank Cihula – agree with Councilman Germano – deal with snowplowers – still spilling it going across the street – going through that spill put you into a skid – other communities ordinances – larger lot size – Lyndhurst has not developable land. John Klements – starting talking with Chris – Council ready to entertain a hunting ordinance. Invited Chris to walk on property – get a visual – typical parcels in the city look like – one acre residential lots. Much of the city is not – on the back of my property – walk around for a long time and not see another structure – 100s of acres of open wooded land. Concerns about space – not really here. Offer to come out and get a visual look of walking on the property. Thirdly – any interested in sharing – background. State of Ohio – very thorough – laws that you have to follow – can say we are not going to allow hunting – bound to follow State of Ohio hunting laws. Very structured, rigid, and safe. Can we also consider if there is a concern going to pass – vegetational impacts that the herd is impacting – have changed because of the amount of deer – we do not have regeneration – completely wiped out the underbrush. Linda Fulton – where is the property? To square off City Hall property in the back.
