## ORDINANCE NO. 2014-9

### **AN ORDINANCE AUTHORIZING THE MAYOR ACCEPT THE PROPOSAL OF RICHARD L. BOWEN + ASSOCIATES, INC. TO PROVIDE PROFESSIONAL ENGINEERING SERVICES FOR THE DESIGN AND CONSTRUCTION ENGINEERING OF THE LAMPLIGHT LANE CULVERT REPLACEMENT PROJECT.**

**WHEREAS**, the City directed Richard L. Bowen + Associates, Inc. to work with the Lake County Stormwater Management Department (LCSMD) to obtain funding for the project costs associated with the Lamplight Lane Culvert Replacement Project; and

**WHEREAS**, the City has determined that Richard L. Bowen + Associates, Inc. is the best qualified firm to provide engineering services for the project due to the firm’s understanding, gained knowledge and history of the project; and

**WHEREAS**, the City has elected to proceed with the Lamplight Lane Culvert Replacement Project and wishes to now authorize that professional engineering services be provided for the project.

***NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WILLOUGHBY HILLS, COUNTY OF LAKE, STATE OF OHIO THAT:***

**SECTION 1.** The Mayor is hereby authorized and directed to accept the proposal, dated December 20, 2013, as submitted by Richard L. Bowen + Associates, Inc., consisting of two (2) pages, attached hereto as Exhibit “A”, providing design services for the Lamplight Lane Culvert Replacement Project at a cost not to exceed **\$30,800**.

**SECTION 2.** The actions of this Council concerning and relating to the passage of legislation were conducted in lawful meetings of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in compliance with all legal requirements including Chapter 107 of the Codified Ordinances of the City of Willoughby Hills.

**SECTION 3.** This Ordinance shall be in full force and take effect at the earliest time permitted by law.
