### A RESOLUTION COMMENDING WILHELMINA “BILLIE” KAMIS FOR SERVING AS THE WILLOUGHBY HILLS’ TRUSTEE TO THE CHAGRIN RIVER WATERSHED PARTNERS.

**WHEREAS**, the Chagrin River Watershed Partners was formed by sixteen cities, villages, townships, counties, and park districts in 1996 in response to increasing concerns about flooding, erosion, and water quality problems; and

**WHEREAS**, today, CRWP’s thirty-seven members represent 99% of the land area in the watershed; and

**WHEREAS**, Wilhelmina “Billie” has been the Willoughby Hills Trustee to the Chagrin River Watershed Partners since its inception, and has served on its Executive Committee, additionally on behalf of member municipalities, Billie was appointed to the Advisory Board of the Lake County Storm Water Agency; and

**WHEREAS**, while serving as an active Trustee to the Chagrin River Watershed, Billie has been able to provide environmental leadership by participating in delivering beneficial services to local decision makers in the context of a watershed approach; she has been involved with the development of comprehensive planning, conservation development, riparian and Wetland setbacks, Erosion and Sediment Control regulations and Storm Water Management regulations; and

**WHEREAS**, Billie has inspired an environmental ethic and an appreciation and understanding of the importance of being good stewards of the environment; and

**WHEREAS**, it is with that same concern and love of the environment that has led Billie to serve her Community by continuing to raise environmental awareness in order to help develop and promote wise stewardship and sound land use practices.
